

# Country Pond Fish & Game Club Rimfire Pistol League Statement of Purpose & League Rules – 2021-22

## Statement of Purpose

The Pistol League was founded and continues to exist for the following reasons:

- To provide safe, recreational .22 caliber pistol competition for interested members of the Club;
- To promote safe pistol shooting practices among the members;
- To encourage the introduction of new shooters to the art and skill of safe pistol shooting; and
- To support traditional Bullseye shooting as a sport;

## League Operations

### Safety:

In the interest of safety, the following rules apply:

- CPF&G range safety rules (available on the Club website & posted in the range).
- In the event that a firearm requires handling for maintenance, adjustment, or general viewing, it may only be done in the second floor main hall of the Club and only after determining that it is unloaded. Any other firearm handling must be done on the firing line.
- During the firing of an official match, only the shooters and the Range Officer are allowed in the range area. Exception: up to two authorized observers or trainees, under the control of the Range Officer, may occasionally be present.
- Eye and ear protection is mandatory.
- Shooters who are not physically able to safely shoot one-handed, or who may feel uncomfortable doing so, may shoot using two hands. Shooters using two hands will not be eligible for individual trophies but will be counted towards team scoring and awards.

### Administration:

League membership is limited to members in good standing of CPF&G.

The schedule each year will be determined at the annual organizational meeting by a majority of the members attending. Each year's schedule will be provided to the members and posted. After issuance, any changes must be made and approved by the team Captains and the League Chairman. This season will run for 16 weeks.

The league officers will be elected each year at the annual organizational meeting by a majority of the members present. They currently consist of:

Team members will select Team Captains and only Team Captains, not individual members, will negotiate disputes between teams, the statistician, etc.

The fees each year will be determined at the annual organizational meeting by a majority of the members present.

For this season, the fees will be:

Registration for the season - **\$2.00**, Weekly match fee - **\$5.00**.

### **Scoring & Equipment:**

A handicap system will be used for team competition. No handicap is used for the individual competition.

The course of fire for league matches and competition will be ten shots slow fire, ten shots timed fire, and ten shots rapid fire, per the current NRA rule book.

In general, everything related to the official league matches will be in accordance with the current NRA rule book and is limited to .22 rimfire pistol and revolvers only. No .22 Magnums are allowed. A Range Officer will conduct all relays. The Range Officer can be any league member not shooting on the relay.

In the event of any unbalanced team rosters, any team, having fewer than the number of shooters of the best represented team, shall have one or more dummy shooters added to their team roster. The score of this dummy shooter shall be the season-to-date net average of the other members of that team.

For competition between two teams, the best four total handicapped scores will be selected from both teams, averaged, and compared. One point will be awarded to the team with best total average. In the event of a tie, one point will be awarded to each team. Two additional points are awarded for the highest total average team score of that week.

The final league team results are determined by the total points each team has earned throughout the full match schedule.

For individual competition in each class, the actual total score for the full match schedule will determine the results. This is calculated by adding up all the actual raw, unhandicapped scores fired by each individual, then subtracting the lowest three match scores. Note: unfired matches are scored as zero (0).

Members may sign up for a maximum of two matches in any one night but may not shoot in consecutive relays.

Shooters must be present to sign up for a relay. No one may sign up another shooter unless that shooter is present.

Matches for individual score may be made up on any league night, any time before the end of the full schedule.

All makeups for team score must be shot on a league night **prior** to the absence.

Targets will normally be scored by "the shooter on the right". After the shooter accepts the scores, he or she will enter them into the computer. The program will perform all calculations and provide weekly reports.

### **Miscellaneous:**

The first three nights of the schedule are used to determine starting handicaps and team makeup.

Initially, teams are made up by the Statistician, based on the member's first three raw scores and are mixed to obtain "balanced ability" teams. Later, people may be added to teams.

League shooting hours are all scheduled Wednesday nights normally between 17:00 (5:00 PM) and 19:00 (7:00 PM). A Range Officer must always be designated and perform that function. This may be the shooting individual if only one person is present.

The league will provide coffee and doughnuts each week at no charge to the members.

There will be no limitation on sighting equipment for team competition; however, no lasers or magnification optics mounted on the firearm may be used. There will be both iron sight and optical electronic – reflex or red-dot – sight classes for the individual competition.

The league will be responsible for the general upkeep of the range, such as lights, cleaning, minor repairs, etc. Funds for such upkeep will come from league receipts.

No smoking, eating, or drinking on the range during Pistol League matches.

Smokers should be considerate of non-smokers. There is no smoking in the building. If you must smoke please do so outside.

Foul language will not be tolerated.

### **Banquet, Trophies and Awards:**

members of the first and second place team will receive trophies.

Members of the third place team will receive Club sweatshirts.

Members of the fourth place team will receive Club t-shirts.

A team plaque will be awarded to the first place team with the names of team members and the shooting season date inscribed on the plaque plate. The plaque will be displayed at the club.

Trophies will be awarded for high score in three categories for both open and electronic sights. They are high score in slow, timed, and rapid fire. A trophy will be given for High Average. A trophy will be given for Most Improved. Trophy upgrades to be paid by the member.

The league will hold a banquet at the end of the league shooting season for all participating league members and their guests. The banquet cost for league members will be covered by the weekly shoot fee. Guests will pay the agreed upon individual cost in advance. Members joining the league after the official start of the league, if they choose to attend the banquet, will be charged a percentage of the individual banquet cost. Banquet cost for the shooter will also be prorated based upon the number of weeks the shooter has participated in the league. Weeks 18-16 = 0%; weeks 15-12 = 25%; weeks 11-8 = 50%; weeks 7-4 = 75%; weeks 3-1 = 100%.
