Law Enforcement Agency Range Use Agreement

This document represents an Agreement between Country Pond Fish & Game Club, Inc. (the Club), of Newton NH, and _____ (Client).

The following considerations between the Club and Client are acceptable and shall be adhered to in exchange for payment of _____, due upon signing of this Agreement.

- The Club will provide Client with a copy of the current Club Bylaws, Standing Rules, Range Rules, and one active Access Key Card.
- Client shall provide liability insurance for officers using the Club range, and written proof thereof to the Club.
- Client may schedule a maximum of two outdoor rifle/pistol range use sessions per calendar year, with each session not exceeding three days, for a total of six days per year. Sessions may not be scheduled on Saturdays or Sundays.
- Client shall be responsible for range cleanup of any detritus, excepting spent pistol or rifle shell casings, generated during range use.
- A request for exclusive use of the Club range by Client must be made a minimum of 45 days in advance, in order for the BOD to consider the request at a regular BOD meeting, and for notice to be posted on the Club website and published in the Club newsletter prior to the date requested.
- It is understood that Client may have specific procedural requirements for qualification by its officers that may conflict with existing Club rules, e.g., movement downrange while firing, etc. Any and all such uses shall be:
 1. at the discretion of the Club Board of Directors;
 2. specifically approved in advance by the BOD; and
 3. limited to specific dates and times when exclusive use of the range has been prearranged.

- Officers of Client agency shall adhere to all Club Standing Rules, Club Range Safety Rules, and the conditions outlined below. Club Range Safety Rules are posted at various locations around the Club, and may be found on the Club website at http://www.cpfgc.com/laws_rules.html
- Client shall be responsible for any damage to Club property caused by officers, agents, or employees of Client, intentionally or otherwise.

No other Club rights or privileges are granted under this Agreement.

No part of this Agreement shall prohibit or disqualify individual officers of Client from applying for their own personal membership in the Club. Personal Club membership by Client officers or personnel would be bound by existing Club rules, policies, and procedures, and is not governed or restricted in any way by this Agreement.

The Board of Directors, by majority vote, may rescind this Agreement for any violations of Club rules, Club range safety rules, or any violation of the conditions of this Agreement.

This Agreement shall be in force from _____ 20_____, through _____ 20_____, but shall not take effect until at least one representative from Client has successfully participated in a Club orientation session.
