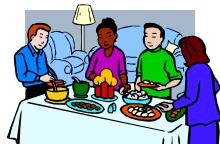

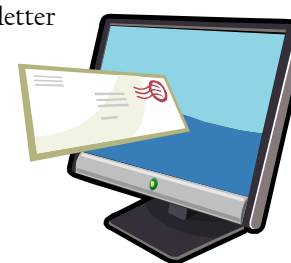
## Newsletters on the Internet
