### Alexander T. "Al" Krawczyk - Member #1387

Alexander T. "Al" Krawczyk, age 95, longtime resident of West Newbury and eighth oldest resident of the town, passed in Hampstead, NH, early Thursday morning, July 23, 2020, at the home of his daughter Kim, and in the loving presence of his devoted family. He was the loving husband of 67 years of the late Jane E. (Flynn) Krawczyk, who passed on June 14, 2019.

Born in Peabody, November 10, 1924, he was one of four children of the late Thomas and Maryanne (Kosidlao) Krawczyk and was a graduate of Peabody High School, class of 1943.

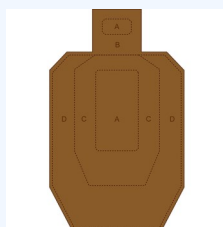
